Nurture Wellness, LLC. (hereinafter referred to as "The Company," "Nurture Wellness," "we," "our," or "us") respects the privacy of individuals who avail our websites, mobile application, and related services (hereinafter collectively referred to as "our Services"). Our privacy policy (hereinafter referred to as "our Privacy Policy") elucidates how we gather, utilize, and disseminate information from users of our Services (hereinafter referred to as "Users", "you", or "your"). By availing our Services, you consent to the collection, use, disclosure, and procedures our Privacy Policy outlines. Apart from our Privacy Policy, your use of our Services is also subject to our Terms of Use.

Information We Gather

We may gather a variety of information from or about you or your devices from various sources, as outlined below.

Information You Share with Us

When a user accesses one of our websites, information that personally identifies the user can be gathered and processed by The Company's employees. Typically, the only information that will be gathered is the user's name, business address, mailing address, telephone number, fax number, e-mail address, and professional licensing information when this information is willingly provided to us. Furthermore, this information can be gathered as a result of the services or the products a user requests information about or purchases from us. Lastly, The Company can gather or process personally identifiable information, such as a user's Internet domain or IP address, as part of the standard operation of our websites, or during the standard course of a user's activities on or use of our websites. In nearly all instances this data is gathered or processed by, or transferred to, The Company's corporate headquarters. When a user accesses our websites, the user is consenting to the gathering, processing, transfer, or use of this information. If a user chooses not to consent to the gathering, processing, transfer, or use of this information in this manner, then the user should not access, or should cease accessing, our websites.

Account Information

If you register for an account on our Services, then we request information about you, such as your name, mailing address, email address, telephone number, and date of birth. We may also provide you the option to share additional information, such as your professional licensing information if you are a licensed health-care practitioner.



Communications

If you reach out to us directly, then we may receive additional information about you. For instance, if you contact us for customer support, then we may receive your name, email address, telephone number, the contents of the message, and any attachments you send to us, as well as any other information you choose to provide. If you sign up to receive updates, offers, or other promotional information, then we will gather certain information from you, such as your email address. Payment Information

If you make a purchase through our Services, then we request information, such as your name, email address, telephone number, shipping address, and billing address. Your payment information, such as your credit card information or other financial information, will also be gathered and processed by a third-party payment processor on our behalf.

Health and Wellness Information

To provide testing services (including generating meaningful results), we request certain health and wellness information from you, including your height and weight, demographic information, health history, medication history, and dietary, sleep, and exercise habits ("Health and Wellness Information"). With your consent, we use your Health and Wellness Information, your test results, and information about the purchases you make through our Services for research, analytics, and product development purposes and to create de-identified or aggregate data that we might share with third parties for their own research and product development purposes. In addition, if you are a customer of one of our third-party partners and you use our Services as part of a promotion with that partner, with your consent, we will share your test results with that third-party partner.

Surveys

If you opt to participate in one of our surveys to assist you in identifying which The Company's products are suitable for you, then we gather information you choose to provide in response to the quiz, such as your contact details, demographic information, and health and medical information.

Biological Sample

To utilize our tests, we may necessitate a biological sample, such as a saliva, urine, blood, or stool sample. We employ your biological sample to provide your test results.

Other Content

We also receive other information or content you choose to provide to us through the Services, such as product ratings and reviews you opt to post to the Services. Please refer to the "User Content" disclosure in the "How We Share the Information We Collect" section, below, for information about how this information or content is viewable by other users of our Services.



Information We Automatically Gather When You Utilize Our Services

Information from Cookies and Similar Technologies. We and our third-party partners gather information using cookies, pixel tags, or similar technologies. Our third-party partners, such as analytics partners and advertising partners, may use these technologies to gather information about your online activities and across different services. Cookies are small text files containing a string of alphanumeric characters. We may use session cookies and persistent cookies. A session cookie disappears after you close your browser. A persistent cookie remains after you close your browser and can be used by your browser on subsequent visits to our Services. Please review your web browser's "Help" file to learn the proper way to modify your cookie settings. Please note that if you delete or choose not to accept cookies from the Services, then you might not be able to utilize the features of the Services to their fullest potential.

Location Information

If you opt to use certain features of our Services, such as to find a licensed health-care practitioner near you, then we receive location information you opt to provide to us, such as your city or Zip Code, or, with your permission, we receive your precise location information. We may also infer your general location information; for example, by using your internet protocol (IP) address.

Device Information

We receive information about the device and software you use to access our Services, such as your IP address, web browser type, and operating system version.

Usage Information

To assist us in understanding how you use our Services and to help us improve them, we automatically receive information about your interactions with our Services, such as the pages or other content you view, the searches you conduct, the products you purchase, your favorites and comments, content you post, and the dates and times of your visits.

Affiliated Entities

Information collected may be shared with our corporate affiliates in accordance with our Privacy Policy.

Service Providers and Vendors

Information collected may be shared with vendors and service providers engaged in the delivery of our Services.

User Content

Our Services enable you to share content such as product reviews and ratings. By default, the content you post on the Services will be displayed on the Services and accessible to other users. We may access, preserve, and disclose your information if we believe it is necessary or appropriate to: (a) comply with law enforcement requests and legal processes, such as a court order or subpoena; (b) respond to your requests; or © protect your, our, or others' rights, property, or safety. For clarity, the disclosure of your information may occur if you post objectionable content on or through the Services.

Asset Transfers, Mergers, or Sales

We may transfer your information to service providers, advisors, potential transactional partners, or other third parties in connection with the consideration, negotiation, or completion of a corporate transaction in which we are acquired by or merged with another company or we sell, liquidate, or transfer all or a portion of our assets. The use of your information following such an event will be governed by the provisions of our Privacy Policy in effect at the time the applicable information was collected.

Consent

We may also disclose your information with your permission.

Third-Party Entities

Our Services may include links to websites, products, or services that are not under our ownership or control. We do not hold responsibility for the privacy practices of these third parties. Please note that our Privacy Policy does not govern your activities on these third-party services or the information you disclose to these third parties. We strive to protect your information by employing safeguards intended to enhance the security of the information we hold. Children's Privacy

We do not intentionally collect, maintain, or use personal information from children under the age of 13, and our Services are not targeted towards children. International Data Transfers

Our Services are hosted in the United States and are intended for visitors located within the United States. Characteristics of protected classifications under California or federal law

Commercial Information

Internet or other electronic network activity information

Professional or employment-related information
